

CHAPTER 125

UNDERAGE AND INTOXICATED PERSONS: POSSESSION: PROOF OF AGE: AND PRESENCE ON LICENSED PREMISES

125.0001 UNDERAGE AND INTOXICATED PERSONS; PRESENCE ON LICENSED PREMISES; POSSESSION; PROOF OF AGE LAWS ADOPTED.

Except as otherwise specifically provided in this ordinance, all provisions of Section 125.07, 125.085, and 125.32 of the Wisconsin Statutes, and as the same may hereafter be amended from time to time, describing and defining regulations with respect to underage and intoxicated persons, their presence on licensed premises, possession and proof of age, are hereby adopted and by reference made a part of this ordinance as if fully set forth herein. Any act required to be performed or which is prohibited by any statute incorporated herein by reference is required or prohibited by this ordinance. The penalty for violation of any provision of this ordinance shall be imposed as provided in Sections 125.07, 125.85, 125.085, Wisconsin Statutes, with the exception that imprisonment shall not be ordered.

Sections 125.07, 125.85, and 125.32, Wis. Stats., adopted by reference shall include but not be limited to the following:

125.0003. FERMENTED MALT BEVERAGES OR INTOXICATING LIQUOR ON PUBLIC PROPERTY PROHIBITED; EXCEPTIONS

A. No fermented malt beverages or intoxicating liquor shall be sold, given away, dispensed, consumed, stored in or brought onto any public property of the Village.

B. No person shall drink from, open a container of, or have in his/her possession an open container of fermented malt beverage or intoxicating liquor:

- (1) On a public highway including the sidewalks adjacent thereto;
- (2) In or on a publicly owned or privately owned parking lot or ramp to which the public is invited;
- (3) In or on any school grounds within the Village, consistent with §125.09(2), Wis. Stats.

C. Exceptions. The provisions of this section shall not apply to the following:

- (1) Licensing requirements of Chapter 23 of this Code;
- (2) Any area that has been temporarily licensed for consumption of intoxicating liquor or fermented malt beverages under Chapter 23 of this Code;
- (3) Green Isle Park.
