

2018 BROWN COUNTY PORT & RESOURCE RECOVERY

POLICY AND RATE UPDATE



The Brown County Port & Resource Recovery Department administers activities for the Port of Green Bay and provides Brown County municipal, commercial and industrial customers cost-effective and sustainable solid waste management systems with the focus on resource recovery primarily through recycling, repurposing, and energy recovery. Brown County is a member of the regional BOW (Brown, Outagamie & Winnebago) Tri-County Solid Waste and Recycling Partnership. These services are among the least expensive and most complete services offered by any operation in the State of Wisconsin. The Port & Resource Recovery Department operates as an Enterprise Fund, solely using revenues gathered through operations to fund its activities.

The BOW Solid Waste Partnership currently uses the Outagamie County Landfill for solid waste disposal.

Waste Transfer Station:

- The 2018 Brown County Waste Transfer Station Gate Rate is \$48.00 per ton.
- Large volume customers contractually willing to commit tonnage for a 5 or 10 year term may be eligible for a lower rate.
- The fee to direct haul waste by

Brown County customers to the Outagamie County Landfill will be \$35.75 per ton with prior approval.

Reminder: The Solid Waste Transfer Station does not accept cash; customers can pay by credit card, check or by setting up an approved credit account. Loads weighing less than 800 pounds will be charged a minimum fee of \$20.00. A load weighing more than 800 pounds will be charged by the gate rate per ton.

Additional resource recovery services include; tires, appliances, scrap metal, lead acid batteries, clean and dirty shingles, construction & demolition (C&D), and clean wood waste recycling. All these resource recovery services have a reduced rate.

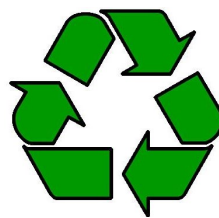
Safety Vests: We now require safety vests to be worn while on the Tip Floor at either Transfer Station. Vests may be purchased for a \$5.00 fee.

Due to the uncertainty in the recycling commodity markets heading into 2018, we anticipate continuing to charge for material coming into the Recycling Transfer Station throughout 2018 and suggest budgeting a fee of \$10/ton for our Partner Rate in 2018.

Hazardous Material Recovery Facility:

Non-hazardous and universal waste items will have a \$0.30/lb fee in 2018 including batteries, all light bulbs, electronics, fire extinguishers, light ballast, adhesive, caulk/glaze/grout/putty, cement/mortar/plaster, latex paint, antifreeze, windshield wiper fluid, cooking oil/grease, and small corded appliances. Automotive lead-acid batteries will be charged \$1.00/unit. Microwaves will be charged \$5.00/unit. Dehumidifiers, miniature refrigerators, small A/C units and small water coolers will be charged \$15.00/unit.
