Jim O'Rourke, 2339 Oakwood Avenue

- Would like the village to move forward now with developing the Department of Natural Resources land along Riverside Drive, across from the Green Bay Correctional Institution (GBCI), as opposed to waiting until GBCI is possibly sold and redeveloped.

Brett Staeven, 2300 S Webster Avenue (North Shore Bank)

- Has a background in economics and finance and came to observe the committee to see how he can get more involved in the community.

PRESENTATION/DISCUSSION: LEVY LIMITS

Julie Beauchamp, Finance Director, gave a brief presentation on levy limits.

- Discussed the history of levy limits and how this affects Allouez.

June 1, 2018 (Economic Development Committee Meeting)

- How levy limits are set-up now makes a community reliant on net new construction, which is not sustainable for rural communities with minimal growth or landlocked communities like Allouez.
- Encouraged the committee to watch a video on YouTube, "Strangled by Levy Limits," sponsored by the League of Wisconsin Municipalities.

DISCUSSION RE: GREEN BAY CORRECTIONAL INSTITUTION UPDATE

Staff said that the village has begun circulating a petition in support of decommissioning the state institution. Currently, there are around 500-600 people that have signed the petition.
