

Village of Allouez 2020 Volunteer Goose Patrol Program

This program is designed to help the Village of Allouez parks department keep parks clean and safe for its users by allowing permit holders the ability to run their dog off leash to chase away and prevent geese from congregating in Village parks. Dog owners shall be permitted to enter Village Park areas with their dog off leash only when geese are present & under the following conditions:

- 1. Dog owners will be issued a permit, indicating the following:
 - a. Dog/owner are permitted in the designated parks from January to December with the exception of May 15 through the July 1, when the geese are molting and cannot fly.
 - b. The permit shall be issued by the Department of Parks, Recreation & Forestry.
 - c. Copies of the permit shall be forwarded to the Code Enforcement Department & Brown County Sheriff's Department.
- 2. Dog/owner shall attempt to push geese from park area.
- 3. Owner must carry the goose patrol permit with them when on goose patrol at the park.
- 4. Owners may enter the parks from dawn to dusk.
- 5. Owner must have control of the dog at all times.

- 6. Owner must clean up and remove any dog waste immediately.
- 7. Dog/owner shall not enter the park if there is an activity or patrons in the park that would be negatively impacted by the presence of the dog (i.e. Special Events, Walk/Run, Recreation Programming, Sports Programming, etc.)
- 8. Dog owners must show proof of dog license for current year.
