

### Dispatched and Generated Calls for Service

# DECEMBER POLICE INCIDENTS



- On Dec 8<sup>th</sup>, at approx. 3:00am, Deputy Nelson was dispatched to the Kwik Trip located at 2203 S Webster Ave, for a disorderly male suspect. It was reported a suspect had just walked out of the store without paying for food. The suspect got into his vehicle but was unable to start it. The suspect then came back into the store and began arguing with staff. Deputies arrived and were able to detain the suspect. Deputies could smell the strong odor of intoxicants coming from the suspect. The suspect admitted to driving here with his vehicle that was currently parked by the pump station. Deputies attempted to have the suspect perform standard field sobriety tests (SFST) but the suspect became disorderly ultimately refusing the testing. The suspect was arrested and transported to the Brown County Jail on charges of OWI 1<sup>st</sup> Offense, Disorderly Conduct, and Retail Theft. The suspect vehicle was towed away from the scene by a local towing company.
- On Dec 12<sup>th</sup>, at approx. 11:38am, Deputy Heupel responded to St. Vincents Hospital to speak with individuals involved in a vehicle versus pedestrian accident that recently occurred at the intersection of Libal St and Kalb Ave. The operator of the vehicle transported the pedestrian, by their request, to the hospital for minor injuries. Both parties involved were identified at the hospital. It was reported the pedestrian was attempting to cross Libal St westbound on Kalb Ave. The operator of the vehicle did not see the pedestrian crossing while attempting to turn northbound onto Libal St from Kalb Ave. An accident report was completed with the operator of the vehicle being issued a citation for Failure to Yield for a Pedestrian. This is a good reminder to all if you are involved in an accident that it is highly recommended to stay on scene at that accident where medical rescue personnel can professionally assess the injuries.
- On Dec 14<sup>th</sup>, at approx 6:21pm, Deputy J. Frye was dispatched to Webster Ave Market, located at 1220 S Webster Ave, for a retail theft in progress. Deputy Frye responded and was able to detain the suspect. The suspect admitted to attempting to steal a bottle of liquor from the store. A DOT record check showed no prior retail thefts/shoplifting on the suspects record. Must appear citation issued to the suspect for Shoplifting 1<sup>st</sup> Offense.
- On Dec 17<sup>th</sup>, at approx 3:15pm, all available deputies working in Brown County were dispatched to the area of the McCormick Assisted Living Home, located at 212 Iroquois Ave, for a report of a missing resident. Staff reported the male resident had left for a walk approx 1 hour ago and had not returned. Multiple deputies responded to the building while other deputies checked the area at local businesses and churches. Deputies searched other rooms in the building and were unable to locate the male. At approx 3:45pm, staff was able to verify by telephone the male was currently at a medical facility for a schedule appointment and was earlier picked up by a caretaker without the facilities knowledge. Deputies were able to confirm the male was at this location and cleared the area.
- On Dec 20<sup>th</sup>, Deputy Rusk responded to an address on the 3300 block of Libal St for a report of fraud on the victim's credit card. The victim reporting having their credit card denied. The victim then looked at their bank statement and observed

over 50 fraudulent transactions from 11/21 to 12/3 in the Fort Worth, Texas area. The transactions ranged from \$1,400 to 87 cents and totaled over \$27,000. The suspect is unknown to the victim. The victim called their banking institution and they advised for a police report to be completed. Incident report completed by Deputy Rusk.

- On Dec 20<sup>th</sup>, Deputy Ebel responded to an address on the 1100 block of Garland St for a report of fraud. The victim reported to Deputy Ebel she received a phone call from who she believed to be Spectrum. The suspect informed her she qualified for a lower rate on her bill. The victim reports giving out her credit card number and social security number. When questioned why they needed her social security number the suspect stated to run a credit check. The victim later called the company Spectrum with more questions and they reported they had never called her. Victim called her credit card company who reported no fraudulent activity at this time. Unknown suspect. Incident report completed with instructions given to the victim on how to freeze her credit line.
- On Dec 20<sup>th</sup>, at approx 11:00pm, Deputy Brown was dispatched to Kwik Trip, located at 2203 S Webster Ave, for a report of a male suspect passed out in his vehicle parked in front of the store. Staff reported the male was earlier in the store and did not know how to use the chip reader. The suspect left belongings on the counter before leaving the store. Multiple deputies responded and located the male suspect passed out in his vehicle. Deputies knocked loudly on the window with the suspect not waking up. Deputies were able to open the unlocked drivers door and wake the suspect up. A strong odor of intoxicants was observed coming from the suspect. The suspect admitted to drinking beer and whiskey this evening. SFST's were completed and the suspect was taken into custody for OWI 2<sup>nd</sup> Offense.
- Dec 26<sup>th</sup> & 27<sup>th</sup>, multiple calls were made to the Brown County Dispatch Center for people standing on the ice over the Fox River just south of STH 172. One call claimed a snowmobile was possibly in the water. Each time deputies were able to verify the ice fishermen were not in distress and were only fishing. Traditionally the Brown County Sheriff's Office gets multiple calls like this when the ice first appears on the Fox River and in the spring time when the ice starts melting. Please use caution paying close attention to the thickness of the ice if you are a fisherman.
