Dispatched and Generated Calls for Service






Calls for Service By Hour of Day









JANUARY POLICE INCIDENTS



- On Jan 5th, at approx. 9:00am, Deputy N. Stueber performed a traffic stop on S. Webster Ave at Kalb Ave for a vehicle traveling at an unreasonable speed. The operator admitted to traveling approx. 50mph in a 25mph zone. A strong odor of marijuana was detected from inside of the vehicle. The operator admitted to having a pipe inside. A passenger stated the pipe belonging to her. Deputy Van Egeren and Deputy Mueller were dispatched to assist. A DOT record check showed the operator did not have a valid license. The vehicle was later searched in which a small plastic bag and a pill bottle were located with trace amounts of green leafy residue inside. A Village of Allouez Ordinance Citation was issued to the female passenger for Possession of Drug Paraphernalia. A traffic citation was issued to the operator for Operating Without a Valid License.
- On Jan 5th, at approx 4:00pm, Deputy N. Stueber and Deputy T. Callow were dispatched to 3500 block of S Clay St for a suspicious vehicle. Dispatch indicated that the complainant said a vehicle had been parked in front of this address for approximately 30 minutes and the vehicle was running. Further notes indicated that the complainant had never seen the vehicle before. Upon deputy arrival the

vehicle was still on scene. The vehicle was occupied by two people with the driver being identified by using their Wisconsin driver's license and the front seat passenger being identified in the same manner. Both said they were playing Pokemon Go. They both said they were sorry and then drove away once informed they were free to go. The complainant walked outside and was advised by deputies of the situation. The complainant was thankful for the police response.

- On Jan 10th, at approx. 4:00pm, Deputy R. Nystrom and Deputy A. Arts were dispatched to Webster Ave Market, located at 1220 S Webster Ave, for a retail theft that had just occurred. It was reported the suspect had just walked out of the store without paying for food. The suspect got into a vehicle parked on Hastings St at S. Webster Ave and drove away. Deputy Arts located the vehicle while it was driving away and performed a traffic stop. The suspect was positively identified while in the passenger seat. A search was completed with the suspect admitting to have needles in the front passenger seat. The vehicle was searched with deputies also finding Heroin inside. The suspect was taken into custody and transported to the Brown County Jail (BCJ) on charges of Retail Theft, Possession of Schedule 1 Narcotics, and Possession of Drug Paraphernalia.
- On Jan 14th, at approx. 1:00pm, Deputy N. Stueber performed a traffic stop on Hastings St. at S. Webster Ave. A DOT record check showed the vehicle registration was suspended for an unpaid parking ticket. Deputy Stueber spoke with the operator and immediately detected a strong odor of burnt marijuana emitting from inside of the vehicle. Deputy M. Berner and Deputy Vogel were dispatched to the scene for assistance. The operator admitted to having a pipe in the vehicle and handed it to Deputy Stueber. The operator also stated there were pills inside the vehicle but was later unable to show any proof the prescription pills were prescribed to him. Due to the operator showing signs of being under the influence Deputy Stueber requested a field sobriety test (FST). The operator refused to perform the FST. A DOT record check showed the operator currently had a revoked drivers license. The operator was taken into custody and was transported to Aurora ER for a blood draw and then to the BCJ on charges of Operating with Controlled Substance 2nd Offense, Possession of Drug Paraphernalia, and Possess Illegally Obtained Prescription.
- On Jan 14th, at approx. 4:00pm, Deputy Plate was dispatched to an address on the 100 block of Hilltop Dr for a report of identity theft. The victim reported she has been dealing with her identity being stolen for years and is attempting to file a police report that multiple accounts have been opened throughout the United States using her personal information. Accounts include Comcast from Las Vegas, NV; Capital One from Georgia; and Home Depot and TJ Max. The victim is unsure how the suspect obtained her personal information and who the suspect would be. Incident report completed by Deputy Plate.
- On Jan 16th, at approx 4:00pm, Deputy B. Plate, Deputy J. Vogel, and Deputy Callow were dispatched to the Webster Ave Market, located at 1220 S Webster Ave, for a retail theft. It was reported the male suspect was becoming uncooperative with staff and attempting to leave. Deputies Callow and Vogel arrived and detained the suspect. On a pat down search a glass pipe was located with a white crystal residue in it. The suspect admitted to smoking crystal meth with the pipe earlier in the day. No other contraband was found on the suspect at this time. Deputy Plate transported the suspect to the BCJ on charges of Retail Theft and Possession of Drug Paraphernalia.
