Preparing for Influenza and Other Respiratory Illnesses, such as COVID-19

There has recently been an increase in media attention on Coronavirus Disease 2019 (COVID-19). Brown County Public Health wants to point out that the risk to the general population in Wisconsin and the United States remains low. It is believed that the main way COVID-19 spreads to others is when someone with the virus coughs or sneezes, and this is the same way influenza and other respiratory illnesses spread. Because of that, Brown County Public Health wants to take this opportunity to remind of important steps they can take to protect themselves and their families.

At this time the Centers for Disease Control and Prevention (CDC), Wisconsin Department of Health Services (DHS), and Brown County Public Health are recommending the following precautions to remain healthy:

- Cover your coughs and sneezes with your sleeve or a disposable tissue, and wash your hands after coughing or sneezing.
- Wash your hands often with soap and water for at least 20 seconds, especially before eating, after going to the bathroom, and after sneezing, coughing, or blowing your nose. If soap and water are not available, use an alcohol-based hand sanitizer with at least 60% alcohol.
- People who are sick should stay home from work, school, or childcare until they are fever free for 24 hours without medicine.
- Avoid close contact with people who are sick.
- Avoid touching your eyes, nose, and mouth.
- Wipe down frequently touched surfaces (i.e., doorknobs, tabletops, phones, keyboards) with a disinfectant regularly, both at home and in the workplace.

Dispatched and Generated Calls for Service






Top 10 Calls for Service By Type

Calls for Service By Hour of Day








Traffic Citations By Violator Race

Traffic Citations By Hour of Day






Written Warnings By Violator Race

Written Warnings By Hour of Day





Operating While Intoxicated (OWI) Offenses



Ordinance Citations





Traffic Crashes

FEBRUARY POLICE INCIDENTS

- Feb 5th, at approx. 1:30am, Deputy C. Brown performed a traffic stop on S Webster Ave at Dauphin St for a vehicle with suspended registration. A DOT record check showed the operator of the vehicle currently had a revoked drivers license. Based on the behavior of the operator Deputy Brown believed the operator may be under the influence of some type of drug. DePere K9 Officer B. Giese arrived on scene to assist. Officer Giese conducted a free air sniff around the exterior of the vehicle and advised his K9 indicated on numerous locations on the vehicle. A probable cause search was performed on the vehicle and multiple THC vape cartridges were located and seized. The operator was issued traffic citations for Suspended Registration and Operating after Revocation. A Village of Allouez ordinance citation was issued for Possession of a Controlled Substance.
- Feb 8th, at approx. 7:30pm, Deputy B. Plate and multiple deputies received multiple calls in the 1500 block of S. Webster Ave of an illegal burn. Dispatch

received multiple calls from citizens ranging from a car to a tree on fire. All complaints made reported a strong smell of something burning. Deputies checked the area and were able to locate the source. Contact was made with the suspect who was burning a christmas tree and a mattress in the back yard. This incident was forwarded to Code Enforcement Officer Mike Lauder. The suspect was issued an ordinance citation for the illegal burn.

- Feb 11th, at approx 10:30am, Deputy J. Rusk was dispatched to the intersection of S Webster Ave at Rosemont Dr. The victim was reporting a female suspect was not letting him out of the vehicle. The victim stated he jumped out of the vehicle at this intersection but left his phone inside the vehicle. The suspect is now refusing to speak with the victim when he attempts contacting her about getting his phone back. The victim wished to report his phone stolen at this time. A written statement was obtained from the victim. The victim reported the suspect was currently homeless and did not know her location. On 2-12 Deputy Rusk was able to confirm with the victim that his phone was returned to him by the suspect.
- Feb 16th, at approx. 12:55am, Deputy N. Delebreau, who was working under the state funded grant for OWI patrol, performed a traffic stop near S Webster Ave at Longview Ave for a vehicle speeding. Upon speaking with the operator Deputy Delebreau observed signs of impairment. The operator admitted to having two drinks. Deputy Brown responded to assist. The operator agreed to perform field sobriety tests (FST). The operator failed the FST and was taken into custody. The operator agreed to a breath test and registered over 0.180. The operator was transported to Aurora Hospital for a blood test. A must appear citation was issued for OWI 1st "Offense. After the blood test was given the operator was released to a responsible party.
- Feb 19th, at approx. 7:45pm, Deputy B. Plate performed a traffic stop for a vehicle traveling with a defective front head lamp. The vehicle was observed traveling on S Webster Ave but pulled into the McDonalds parking lot, located at 1903 S Webster Ave, before police lights were activated. Deputy Plate noted the operator and passengers were acting very suspicious for a routine traffic stop. The operator later admitted to Deputy Plate there were needles in the vehicle. A records check showed the operator and passengers had prior drug convictions. A DOT record check also showed one of the passengers with an active warrant for their arrest. Deputy N. Dennis arrived with his K9 partner. Deputy Dennis conducted a free air sniff around the exterior of the vehicle and advised his K9 indicated on numerous locations on the vehicle. The passenger with a warrant was taken into custody. Deputies located two needles on this person at this time. The vehicle was searched with other needles located. The passenger taken into custody was transported to the Brown County Jail on their active warrant and was issued a Village of Allouez ordinance citation for Possession of Drug Paraphernalia.
- Feb 26th, at approx. 3:30pm, Deputy Plate and D. Dow were dispatched to an address on the 900 block of Allouez Ter for a suspicious situation. Dispatch advised there was a red, SUV in the driveway of this address with a window smashed out. Deputy Plate made contact with the owner of the vehicle. The victim reported him and his wife arrived home last night around 6PM and the window was not broken. The victim advised they both were home all night and day with their children and did not observed anything suspicious around their home. The victim advised he does not know anyone that would want to do this to him and he does not know when this happened. Deputy Plate later made contact

with the neighbor via phone who had a doorbell camera on their house and they advised the camera picked up nothing suspicious. At this time, no further information to report.

- Feb 26th, DEO Vogel was asked by village staff to investigate an illegal dumping at the Allouez Village Waste Yard Site located at 809 Lebrun St. Over the weekend someone had dropped off a large television. **The Village of Allouez is no longer accepting electronics and appliances at the waste site.** DEO Vogel was given photographs from the surveillance system located on site. A license plate and driver were easily identified using the camera system. DEO Vogel was able to speak with the registered owner of the vehicle at their home. The suspect agreed to follow DEO Vogel back to the waste yard site and take back the television he dropped off.
- Feb 26th, Deputy Stueber was dispatched to an address on the 500 block of Chardonnay Ct for a fraud complaint. Dispatch indicated that the complainant was frauded by someone saying he had to reset his password for his Apple account and gave his credit card, SSN, and personal information because he thought it was real. The victim reported on 2/25/2020 at around 3:00 PM, he received an email from whom he thought was Apple about a purchase he did not make. The victim followed the prompts which had him enter his credit card information, social security number, and personal information. The victim then called Apple support who told him that they would never ask for a social security number and that the email was fake. The victim immediately closed his credit cards and notified his bank. The victim is not out any money at this time and also reported to the Social Security Administration about giving out his social security number. The victim also reported this to the FTC (Federal Trade Commission).
- Feb 27th, at approx. 4:50am, Deputy B. Coffey and several other Brown County deputies were dispatched to an address on the 1300 block of Bismarck St for a reported burglary in progress. Dispatch reported an ex-boyfriend had broken into the house and was now destroying the 1st floor. Deputies arrived and were able to immediately take the suspect into custody as he was leaving the home. The rest of the house was cleared with only the complainant/victim found inside. The victim reported his roommate called him stating her ex-boyfriend had called her and was now on his way over to the house. The roommate reported her ex was intoxicated and upset. The victim later heard knocking on the door and then the door being kicked in. The suspect was heard yelling and throwing items around the household. The suspect was transported to the Brown County Jail on criminal charges of Criminal Damage to Property, Criminal Trespass to Dwelling, and Disorderly Conduct.
- Feb 27th, at approx. 10:30am, Deputy Stueber was dispatched to the Kwik Trip located at 2203 S. Webster Ave for a report of retail. The store manager reported they had video evidence of a female suspect on two different occasions stealing cheesecakes. Video surveillance of the suspect shows her concealing the cheesecakes in her purse and then walking out of the store without paying for them. The manager provided the suspect's name to Deputy Stueber. Deputy Stueber was able to speak with the suspect who admitted to the thefts. The suspect was issued two different retail theft ordinance citations. Both citations were made must appear to speak with the village judge on the court date provided.
