Please join us for the first public involvement meeting to discuss the proposed improvements for Libal Street between STH 172 and Kalb Avenue.

The meeting is scheduled for Wednesday, September 22, 2021, from 5:30 to 7:30 P.M., at the Village of Allouez Village Hall, located at 1900 Libal Street. A brief presentation is scheduled to begin at 6 P.M. The remainder of the meeting will follow an informal, open house format allowing you time to review the displays and discuss your questions and concerns with project representatives.

The proposed project will reconstruct Libal Street from STH 172 to Allouez Avenue and replace the existing pavement from Allouez Avenue to Kalb Avenue. The preliminary design of the reconstruction section from STH 172 to Allouez Avenue will investigate options for roadway widths, bike lanes, parking, and sidewalks. New storm sewer will be constructed in this section. New sidewalk is proposed between Greene Avenue and Allouez Avenue on the west side of Libal Street. The pavement replacement section from Allouez Avenue to Kalb Avenue will construct new asphalt pavement while maintaining the existing curb and gutter and existing sidewalk. Existing curb and gutter and sidewalk in poor condition will be replaced as necessary. New sidewalk is proposed north of Beaupre Street to Kalb Avenue on the east side of Libal Street. The existing storm sewer will be reviewed, and spot repairs completed as necessary. The proposed improvements will be funded with 80 percent federal funding and 20 percent local Village of Allouez funding. The project is anticipated to begin construction as early as 2024.

The purpose of the meeting is to introduce the proposed project and listen to your comments, concerns, or suggestions. This is an opportunity for you to offer input into the design process. Additional public involvement meetings will be held in late spring 2022 and fall 2022 to gather input on the proposed improvements as the design is further developed.

We look forward to meeting with you. If you are deaf or hard of hearing and require an interpreter, you may request one by contacting me at least three working days prior to the meeting. Wheelchair accessibility is available at the meeting site.
